SUBJECT: Release of Victim's Backpacks and Personnel Effects

The following guideline needs to be utilized by all personnel releasing evidence back to the victims.

1. A written request must be made to Chris Andrist about specific items to be released. Chris will then OK the request and then give the request to A. Simmons or C. Loptien to release the evidence. The evidence will be examined by one of the above listed people to see if it contains any evidentiary value.
2. The evidence will be released at the evidence vault with the victim services representative and one of the following people: C. Andrist, A. Simmons or C. Loptien. The evidence will have the chain-of-custody initialed by the Victim Service representative at this time.
3. A return-to-owner(RTO) sheet will be given to the VS representative. The RTO sheet will be filled out by the representative and the owner of the evidence.
4. The original RTO sheet will be returned to the evidence vault. A copy of the RTO sheet will be directed to C. Loptien in the lab. A copy should be kept by Victim Services for their records.
5. No evidence will be released to the victims if the item has any Biohazard on it. (Unless the blood may be collected by a swab by C. Andrist or C. Loptien of the lab).

This guideline is intended to keep the release of evidence a smooth process for everyone involved. It is also intended to keep good records of the released evidence as well as allowing only authorized personnel to make decisions on the release of the evidence to the victims.

SUBJECT: Release of Victim's Backpacks and Personal Effects

When family members are asking for the return of evidence from the Sheriff's Office, please reference the attached memo from Chris Andrist dated June 14, 1999.

1. A written request must be made to Chris Andrist about specific items to be released. **Have the families be as specific as possible. Ask for all the effects of a victim rather than a notebook or backpack.** Chris will okay the request and pass it along to Al Simmons or Chris Loptien to release the evidence. Remember that all evidence will be examined to see if it contains any evidentiary value.
2. The evidence will be released at the evidence vault with the victim services representative and one of the following people: Chris Andrist, Al Simmons or Chris Loptien. The evidence will have the chain-of-custody initialed by the Victim Service representative at this time.
3. A "return-to-owner (RTO)" sheet will be given to the VS representative. The representative and the owner of the evidence will fill out the RTO sheet.
4. The original RTO sheet will be returned to Jo Ella in a timely manner.
5. The original RTO sheet will be returned to the evidence vault. A copy of the RTO sheet will be directed to Chris Loptien in the lab. A copy will be made for Victim Services (Golden) for our records.
6. No evidence will be released to the victims if the item has any Biohazard on it. If an authorized person in the lab can clean the blood from the item, then Chris Andrist might reconsider release of the item.

Please follow the above steps at all times when working with deceased and injured families as well. When in doubt of what a family is asking for, try to get them to be as specific as possible. In addition, since many of these families may not know all the items their child had that day, the final entry in your written request should read, "any additional items for (child's name)." The intent is to attempt to return all items belonging to the individual at one time. If these steps are followed, we will not have as many requests to the lab for return of property as you have had recently.




