Anthony Wayne Arnold, Building Engineer, Columbine High School (CHS), was interviewed at CHS. After being advised of the identity of the Special Agent and the nature of the interview, Arnold provided the following information:

Arnold said he has been the Building Supervisor at CHS for approximately two years and has worked for the Jefferson County School District for approximately nine years, at a variety of Jefferson County Schools as a building custodian.

Arnold described the video taping system that was in place in the cafeteria as consisting of four cameras located at the northeast corner near the soda machines, the northwest corner near the entrance to the faculty lounge, the southwest corner located above the windows, and at the southeast corner near the stairway. All cameras are set to point into the cafeteria area and operate on a clockwise "rollover" system. Each camera terminates at a VCR which is located in a custodial closet in an area east of the cafeteria. Arnold and one of his subordinates, Jay Gallentine, are the individuals that usually change the tapes. Arnold showed the interviewing Agent the location of the closet and the cameras.

Arnold said the purpose of the taping system is to document activity in the cafeteria, especially students leaving trash at the tables. Arnold said it is his procedure to periodically review the tapes to see if there is any trash located in the cafeteria and if trash is discovered to review the tape to find out which group of students left the trash, and then try to identify those students and have them clean up their mess. Arnold said that if he finds trash on a tape he will generally pull that tape out of the VCR and place it on top for later review.

On April 20, 1999, Arnold said he believes he started the tape in the morning between 7:00 am and 8:00 pm, then probably reviewed the tapes sometime between 10:00 am and 11:00 am, and may have seen trash or an object on the table and removed that tape and re-inserted another. He said he would have unlocked the door at approximately 11:10 am, and put in another

re-wound tape to record lunchtime activity since that is a high volume time in the cafeteria.

He definitely remembers changing the tape before lunchtime, but is less sure whether or not he changed the tape several hours earlier. He said he probably did but has no specific knowledge of changing the tape between 10:00 am and

Arnold said that the normal procedure is for Jay Gallentine to do a walk-through after each class period when classes occupy the cafeteria, and he believes that Gallentine would have done a walk-through at around 10:15 am. Arnold said he is sure that the door to the custodial closet where the VCR is kept was locked each time he went there on April 20, 1999.

Arnold said that on April 20, 1999, after the tape change which he believes would have occurred around 10:30 am, he went into the kitchen, got his lunch and went to his office where he ate lunch with John Curtis and Jay Gallentine. After lunch he returned to the custodial closet between 11:10 am, and 11:15 am, and changed the tape. After the tape change he walked back into the kitchen and heard Gallentine's voice on the radio saying words to the effect that he needed Neil Gardner, whom Arnold identified as the campus security policeman, in the west parking lot. Arnold said Gallentine's voice was agitated so Arnold went into the cafeteria area from the west entrance and saw several students looking to the west into the parking lot.

Arnold said he saw two students laying in the parking lot that appeared to have been injured. At that time he also noticed a student on his knees outside the window area to the west with a severe facial wound. Arnold said he-also saw a student laying outside the door of the cafeteria. One student wanted to pull this student in and Arnold stopped him, feeling that the student was more likely to get medical attention outside than inside. Arnold said that students both outside and inside were ducking from what Arnold thought were gunshots that appeared to be coming from the north or northwest. He said the student that had been shot in the face was also facing to the north so Arnold inferred that the threat came from that area.

Arnold then ran into the faculty lounge to ensure someone was on the telephone calling 911. Once he verified that was in fact taking place, he ran back out and found the student that had been lying down had pulled himself half in and half out of the door. At that time Arnold noticed that the student had been shot in the back and Arnold suggested that they not move him further. Arnold then went around the serving line of the cafeteria and heard and felt a large "boom" which threw him to the ground. He believes the explosion came from the cafeteria area. He said he then crawled to the kitchen where he found three cooks and two more students ducked under appliances in the kitchen. At that time he noted Jay Gallentine and John Curtis running in the vicinity of the kitchen and he could hear bits and pieces of conversation over his two-way radio from persons outside the kitchen.

At that point Arnold said things begin to quiet down somewhat so he went to the storage room and noted students had began to huddle in there, so he went back out and got the cooks and another teacher whom he believed was a social studies teacher, and helped them into the storage room. He said the social studies teacher had been wounded in the leg and was obviously in a great deal of pain. He said the teacher had been hit with something from the explosion and the teacher said it felt like he had been hit with a "full beer can."

Arnold said shooting was going on while he was in the kitchen and until the time they went into the closet. Even after they were in the closet he would hear rustling, shots and screaming from an area he thought was above the kitchen. He estimated that the shooting went on for 20 to 30 minutes and then became sporadic. Arnold did not know at any point where the shooting was coming from other than at some point it was louder and then became quieter. After approximately 1 % to 2 % hours, Arnold and the students were directed out of the closet by police officers and taken out the west door of the cafeteria. Arnold thinks that occurred at around 3:00 pm. Arnold said the day of the incident he was wearing a white T-shirt and jeans.

Arnold said that he did recall a student who was performing community service working in the cafeteria prior to the incident. Arnold said the student's name was possibly and would be listed on a sheet in the custodian's office.

Jay Gallentine, Building Custodian, Columbine High School, was telephonically interviewed. After being advised of the identity of the Special Agent and the nature of the interview, Gallentine provided the following information:

Gallentine said he is a Building Custodian at Columbine High School. His shift begins at approximately 5:00 am, and ends at around 2:00 pm. On April 20, 1999, he came to work at approximately 5:00 am. He was dropped off by his wife, Linda, and as is his usual habit, opened the gates to the parking lots. Once he had opened the gates, he entered the school through a door located on the northwest corner of the school near the cooling towers. He unlocked the janitor's office and called security to let them know he was in the building.

Gallentine remembers that he had a job he had to complete the first thing in the morning and immediately went out and changed the lettering on the marquee in front of the high school. He then changed garbage bags in front of the school. Once he had raised the flag by the turnout in front of the school, he returned to the janitor's office.

After turning on the lights in the cafeteria, he propped the eastern-most door to the cafeteria open so that the head cook, whom he identified as Linda Tiplett, could enter. He recalls that after turning the lights on he did a cursory examination of the cafeteria and at that time saw no bags or backpacks on the floor of the cafeteria.

Gallentine said it is his habit to walk through the cafeteria at the commencement of each class period during the course of his shift. He does not recall seeing any objects unattended on the floor of the cafeteria on any of his walk throughs that day. Gallentine said that if he did see an object it was his habit to put the item on the table so that the person who lost or left it could return and easily find it. He is quite certain that he would have noticed an odd shaped duffel bag or larger container during one of his walk throughs.

Gallentine did note however, that on April 20, 1999, a student who had been assigned community service was in the

cafeteria helping to sweep the floor and wipe down tables and may have seen something. Gallentine does not know the student's name.

Gallentine said that it was his job to wait at the northwest corner of the kitchen until approximately 10:30 am when he would go into the kitchen and get his lunch. On April 20, 1999, he said he was waiting at the northwest corner until approximately 10:50 am, when he went into the kitchen to prepare his lunch. Around 11:15 am, Gallentine had noticed dirty tables near the doors to the faculty lounge and was beginning to clean those tables when a young girl came running into the cafeteria and said words to the effect of, "Someones been shot." Gallentine looked out the window and saw a student laying in the parking lot close to the soccer field.

At around that time a window on the south side of the cafeteria with a Columbine symbol etched in it was blown out by either an explosion or a bullet. Gallentine screamed, "Get down" to students around him and at that time recalls hearing sporadic gunfire. Gallentine directed students to get under tables as the qunfire increased. He noticed some students were running toward the stairs and the double doors leading to the south parking lot.

Gallentine recalls hearing gunfire upstairs above the cafeteria and he went to the stairs that led to that area. He is not sure but thinks he went all the way to the music room located on the northeast side of the building where he saw students fleeing in all directions. He then retraced his steps back toward the cafeteria and library area. As he approached the top of the steps in front of the library leading to the cafeteria, he encountered a teacher he identified as Teresa Lara, who said words to the effect, "Jay, Dave Sanders has been shot. Call an ambulance." Gallentine thinks Lara also may have said that two students had been shot, but he is not sure.

Gallentine reached for his walkie-talkie and as he turned back toward the library he saw a student in a black trench coat holding a pistol and what Gallentine thought was a long barreled grenade launcher. He said the shoulder weapon was strapped across the individual's chest with the butt of the weapon on the right side of the individual's body. For a brief moment Gallentine and the subject were face-to-face and he

noticed that under the trench coat the individual appeared to be wearing a white shirt. Gallentine did not recognize the individual. Gallentine turned and ran to the landing leading to the cafeteria when he heard shooting behind him. He believed at that time the individual in the trench coat was coming down the stairs behind him.

Gallentine believes that around this time he saw John Curtis, another custodian, and Eric Krizer, whom he believes is a social studies teacher. He, Curtis and Krizer were moving toward the kitchen when he heard a large explosion behind them. Gallentine believes it was a pipe bomb and it blew Krizer down to the ground. He and Curtis picked Krizer up and carried him into the kitchen where they encountered a student, whom he identified as Dusty Hofschnieder plus three other unidentified students. Gallentine warned them back and the students went toward the storeroom area in the rear of the kitchen.

Gallentine, Curtis and Krizer huddled down behind the dishwasher table and Gallentine closed the door behind them. He is not sure why the gunman did not follow them into the kitchen. He does recall that several students insisted on leaving and left on their hands and knees out the western side of the kitchen toward the door that led to the west parking lot.

Gallentine encountered Tony Arnold, Judy Greco, and a number of other students in the northern storeroom area of the kitchen and recalls that Tony Arnold and 17 students entered the storeroom and locked themselves in. He believes the cooks were locked in their office.

Gallentine then left the kitchen and went back through the cafeteria to the auditorium and found the door unlocked. As he entered the auditorium he noticed several students sitting near the top of the auditorium and he saw a teacher whom he identified as Mr. Andris, sitting with the students. Gallentine motioned the students to come to him and all the students came down to the double doors leading into the auditorium. Gallentine told them there was an extreme emergency and to get out as quickly as possible. He believes 50 to 80 students ran out the auditorium and down what he referred to as the business hall which leads to the eastern lower section of the school.

Gallentine believes that the movement out of the auditorium drew the attention of the individual in the trench coat and as he stood at the base of the stairs he looked up and saw at least one of the individuals who was doing the shooting, coming around the corner of the stairs. Gallentine believes it was the same man he had seen in front of the library. Gallentine ran back through the cafeteria and as he ran through the cafeteria, he noticed a student lying on the floor. When he got to the end of the cafeteria Gallentine did not see the subject, so he went back upstairs and saw John Curtis near the landing of the stairs.

Gallentine again saw the shooter standing in front of the library and it is his recollection that as he and Curtis began running down the stairs together, the shooter began firing rounds at them. Gallentine said that as he and Curtis entered the kitchen an explosion occurred behind them and he could hear objects hitting the metal door on the serving line.

Once he and Curtis were on the ground in the kitchen, they crawled underneath a large industrial oven, but realized that hiding place was not secure. Around this time Gallentine heard what he described as a "whoosh" and saw fire in the vicinity of the cafeteria and the kitchen. Gallentine determined that he was in a "bad place" and moved further into the kitchen. He then entered the walk-in cooler and Curtis went into the freezer. After approximately one minute, Curtis, who was carrying a radio, called Gallentine and told him to open the door and that he was coming in the walk-in cooler. The door opened and Curtis entered the walk-in cooler.

They propped a food cart against the door and prepared several large objects to use as weapons in case the gunman opened the door. Gallentine kept trying to make contact with two individuals, whom he identified as Sid and Andy, on his radio. Gallentine said that Andy answered and Gallentine told him they were in the cooler and to tell him when it was safe to come out. Gallentine recalled hearing gunshots for a long period of time while he was in the cooler, but could not tell where they were coming from. He believes he saw shadows moving around the kitchen but did not see anyone.

Gallentine believes he heard shooting for up to an hour to an hour and thirty minutes after the initial incident. He said at one point there was approximately a 20 minute interval of silence and then the shooting began again. He recalled looking at his watch at 1:50 pm, and around that time recalls hearing shooting and then he glanced at his watch at 2:25 pm, but heard nothing.

At approximately 2:35 pm, a voice on the radio told him that the SWAT Team was outside the doors and Gallentine and Curtis came out of the cooler.

Gallentine is sure he did not change the tapes on April 20, 1999. He also said he was wearing a white T-shirt with a Columbine emblem and blue jeans. He said he is a white male, approximately 5'6 %" and weighs 140 pounds. Gallentine is further described as follows:

On May 4, 1999, James Royce Washington (PROTECT IDENTITY), also known as Jim Washington, 6020 Snowbird Drive, Colorado Springs, Colorado 80918, was telephonically contacted at his residence. After being advised of the identity of the interviewing agent and the nature of the interview, Washington voluntarily provided the following information:

Washington advised that at the Tanner Gun Show at the Denver Merchandise Mart in Commerce City, Colorado on the weekend of November 21 - 22, 1998, he and Ron Hartmann rented their tables from a friend of Washington's, Bruce Guthridge or Gutridge. Washington was unsure of the exact spelling of the last name.

Washington described Guthridge as being a gun dealer from the Loveland, Colorado area, northwest of Denver, who he has known for some time. He believes that Guthridge holds a Federal Firearms Dealer's license. Washington would see Guthridge at various gun shows and from time to time, he would assist Guthridge by watching his table while Guthridge went to the bathroom or to get something to eat. Due to his friendship with Guthridge, Washington advised that he and Hartmann would rent their tables at shows from him in order to help Guthridge out with the cost of the rentals.

Washington stated that inside the Merchandise Mart at the Tanner Gun Show, their tables were located near the south side of the east restrooms, in front of some telephone booths. Furthermore, he advised that Guthridge usually rented "end-cap" tables, at the corner of an aisle and they would rent one side of this set-up from him.

Heckler was being interviewed based upon his known friendship with Eric Harris and Dylan Klebold, both members of the Trenchcoat Mafia (TCM), and to his knowledge of the Columbine High School incident that occurred on April 20, 1999. Heckler stated that he had been good friends with Dylan Klebold for years. In response to the questions pertaining to his computers, he replied that he does own several computers and considers himself to be proficient in using computers.

He stated that he corresponds via the Internet on the World Wide Web via www.Concentric.Net/-kibbz. He further stated that he has played computer games with Dylan Klebold and Eric Harris. Heckler advised that Klebold did not maintain an E-mail address. Eric Harris was known to maintain an American On Line (AOL) account with the computer name of "REBDOOMER." He stated that during the summer of 1997, he stopped being friends with Eric Harris for reasons not specified. He further stated he played the computer game known as "Quake" with Klebold, which is a game on the Internet that can be played on servers anywhere. Heckler stated he "Never" played the game "Postal."

Heckler advised that he maintains two computers in his home that he described as building in class while at CHS during approximately December, 1996. He stated he downloaded information off of his computer on Tuesday, April 20, 1999, following the CHS incident. He stated he downloaded the

"Anarchist Cookbook" and other information that was then placed into a coffee can and placed behind the furnace adjacent to Zachery's bedroom. He stated he "hid" the computer disk because he was concerned with the information contained on the disk. Heckler willingly provided the whereabouts of the computer disks when asked directly regarding its content and whereabouts. He stated he did have the CHS locker combinations to all of the students maintained in his computer system.

Heckler advised that he did not have prior knowledge that Klebold and Harris were going to commit or execute such an act of violence at CHS. Heckler stated that he does not consider himself to be a member of the TCM.

Heckler stated he heard a rumor following the CHS shooting from friend, Katy Trojan, that , and lith grader, and grader, had knowledge "something" was going to happen. Heckler stated that he was told this from Trojan on April 22, 1999, at approximately 4:00 p.m. this morning between 10:00 a.m. He stated he called and 11:30 a.m. reporting that sounded unsure of what was going on. He stated wondered about also wondered about where the guns used at CHS came from.

Heckler stated that he would have notified Neil Gardner, Jefferson County Sheriff's Department, School Resources Officer (SRO), assigned to CHS, if he would have known something was going to happen. He further stated he did not think anybody knew an incident was going to happen prior to the April 20, 1999, shooting.

Heckler provided consent to seize his two (2) computers and multiple disks from his residence while his father, Mark Heckler, was present. Both Zachery and Mark Heckler were cooperative during the interview.

Elvig responded to the home of Randy Brown, 8003 South Vance, Littleton, Colorado, telephone (303)972-0602 to pickup a copy of an E-mail and some AOL Instant Messaging regarding Brenda Parker. Randy Brown is the father of Brooks Brown. Attachment A is the E-Mail and AOL Instant Messaging copies furnished by Brown.

Brooks Brown explained that he had received the documents via the Internet from Catherine Deely, 1868 Commonwealth Avenue #A, Brighton, Massachusetts 01235 (old address), 92 Corey Road #3, Brighton, Massachusetts 01235 (new address), telephone (617)713-3872(h), (617)656-4959(vm). Deely had setup an Internet Website to support the victims of Columbine High School which included Brooks Brown. Brooks Brown began communicating with Deely over the Internet and the telephone. Deely's e-mail address is bostnbytch@aol.com. Deely met Brenda Parker via the web page and began communicating with her. Parker resides in Westminister, Colorado and has an e-mail address of VoDkAREB@aol.com. Brooks Brown has also communicated with Parker via the Internet and the telephone. Parker claims to be an old girlfriend of Eric Harris.

The Browns are concerned that based on the e-mail and the instant messaging, that Parker may be attempting to purchase a gun and go to Columbine High School to finish what Harris and Dylan Klebold started. Deely was advised that the information would be turned over to the Federal Bureau of Investigation and she advised the Browns that she was willing to cooperate.

ROBYN KAY ANDERSON, born 11/04/80, was advised of the identity of the interviewing agent and the purpose of the interview. ANDERSON was interviewed at the office of her attorney, MICHAEL G. ROOT, 1999 Broadway, Suite 3205, Denver, Colorado, telephone 303-675-0500, who was also present during the course of the interview. INV GARY CLYMAN, Colorado Attorney General's Office, coordinated and set-up the interview with ROOT, and also participated. ANDERSON's parents were not present. ANDERSON provided the following information:

ANDERSON had lived in the Columbine area for approximately four years and moved from Fort Collins. ANDERSON's father lived 20 minutes East of her. ANDERSON's mother was presently in Minnesota visiting an aunt.

ANDERSON started checker school this week at the Safeway store located on the corner of Ken Caryl and Pierce, in Littleton.

ANDERSON had a 4.0 grade point average in school and took a lot harder classes than the other Trenchcoat Mafia (TCM) members. ANDERSON was also in the National Honor Society. ANDERSON had taken classes with the jocks at Columbine High School (CHS) and never had any problems with them. ANDERSON pretty much got along with the other students at CHS. ANDERSON normally got out of school sometime between 10:20 am and 11:50 am.

ANDERSON recalled a "huge" fight last year involving 20 TCM members and some CHS freshmen behind the local Blackjack Pizza. ANDERSON did not know what started the fight.

DYLAN KLEBOLD also got along well with the other students at CHS. He never talked about being abused by anybody. ANDERSON did not consider KLEBOLD to be a violent person. ANDERSON did not consider herself to be a violent person.

KLEBOLD and ERIC HARRIS had outside interests such as bowling, shooting pool at KLEBOLD's house, music, and the computer game, "Doom." ANDERSON had never played "Doom" with them. ANDERSON recalled KLEBOLD bragging to her that he, at one

time, had beaten HARRIS in total number of kills while playing the game.

KLEBOLD and HARRIS never talked about going hunting.

ANDERSON accompanied KLEBOLD and HARRIS to a gun show, circa December 1998, and was present when they procured some of their weapons. ANDERSON knew they were not old enough to buy a gun and that she had to be present.

About a week after the purchase, ANDERSON informed a friend of hers, PAT MCDUFFY, that she had gone to a gun show with KLEBOLD and HARRIS, and that they had bought three weapons.

KLEBOLD and HARRIS asked ANDERSON not to tell anyone they had bought the guns because they were afraid someone would take them away. They said they wanted to have the guns for a long time. They assured ANDERSON they would not tell anyone she had been with them when they got their guns. ANDERSON recalled making a comment to them at the time, "you're not going to shoot anyone, are you?" They answered no.

ANDERSON did not know why KLEBOLD and HARRIS picked her to buy their guns for them. ANDERSON figured at the time, if she did not do it, someone else would.

ANDERSON made sure that her name did not appear on any paperwork when KLEBOLD and HARRIS obtained their guns.

KLEBOLD and HARRIS never really talked about guns, or being interested in them.

ANDERSON regretted posing in the CHS senior class picture with KLEBOLD and HARRIS, acting like they were shooting guns. The picture was taken during the second period. not talk about posing that way ahead of time. KLEBOLD had put his left arm around ANDERSON and pretended to hold a gun, so she did too.

ANDERSON only knew two of the victims at CHS: LISA KRUTZ and LAUREN TOWNSEND. ANDERSON did not attend any of the memorial services after the shooting because she did not know any of the victims well enough.

ANDERSON did not think that KLEBOLD or HARRIS told any of their friends about their violent plans. If ANDERSON would have been told in advance, she would have done everything possible to talk them out of it, or informed KLEBOLD's parents. ANDERSON could think of no reason why anyone would say she knew about their plans ahead of time.

No one has ever informed ANDERSON that they suspected anyone else of being involved in the CHS shooting.

ANDERSON hosted a party at her home on Friday night, 03/26/99. Approximately ten to fifteen people attended, including HARRIS. KLEBOLD was in Arizona with his parents at the time, visiting the University of Arizona. ANDERSON recalled that KELLY BROWN and her boyfriend had been at her party, as well as MONICA and her friend DEBBIE, and another individual named TRAVIS. HARRIS seemed to be his normal self at the party, quiet and keeping mostly to himself. ANDERSON initially contacted HARRIS to find out where KLEBOLD was at and ended up inviting him to her party.

After the shooting, ANDERSON had visited KLEBOLD's mother at their residence and she told ANDERSON that KLEBOLD and HARRIS had dinner together at the Outback Restaurant the night before the shooting. HARRIS had coupons and liked eating there.

Keating stated she has been employed with CHS for six years and is known as the "School Narc". She stated that on April 20, 1999, she had gone to a breakfast in the morning which was sponsored by the DECA Association at the Wellshire Inn located off of Hampden and Colorado Boulevard, Denver, Colorado. Keating stated the purpose of the breakfast was for the "DECA Kids," which is described as a business education program. Keating stated CHS Principal, Frank DeAngelas, was present for the breakfast. A list of students present for the DECA breakfast is maintained by Kathy Frommer, CHS faculty member, teaching business education. Frommer is reported to have a list of the DECA students invited and who showed up. Keating stated she returned back to CHS at approximately 11:00 AM.

Keating stated she parked in the faculty parking lot and entered CHS through the front doors located on the east side of the building. Keating went to her office located in the hallway to the north of the main office where the school administration offices are located. She picked up her school radio which she refers to as her "Ears." Neil Gardner, a Jefferson County Sheriff's Department Deputy assigned to CHS, and Andy (Last Name Unknown) (LNU) were not in the main office at the time she showed up. Keating stated she remembers their absence because she was "dressed up" and wanted to show Neil and Andy how she looked. Keating stated Neil Gardner was believed to be in his police vehicle at around 11:00 AM. Keating stated she was hanging out around the CHS trophy case with students who were

commenting and "teasing" her regarding being dressed up. Keating stated she took a walk past the library, down to the lunch room, down to the cafeteria through the kitchen to show the cafeteria ladies how she looked. She stated that students in the cafeteria were clapping and cheering at how she was dressed up. She entered the faculty lounge located adjacent to the kitchen which she stated was empty. Keating stated she returned to her office at exactly 11:15 AM and noticed the red light on her office telephone flashing indicating she had a message. She checked her voice messages and had a message from her husband which she returned. When she called her husband, she was placed on hold, awaiting for her husband, Tom, to answer the phone. She stated that she recalls CHS Administrator Peter Horvath declaring a 911 emergency via the radio, "There's a shooting in Mrs. Grecko's Room." She recalled hearing "Syd, Andy, Neil, shooting in Mrs. Grecko's Room." Gunshots were heard which are described as three or four "pops." Breaking glass was heard in the area of the front doors. Another CHS Administrator, Chris Mikesell (female), was heard saying, "Oh my God, gun, lay down, get down." Keating saw an unidentified subject wearing black come through the front doors shooting at the windows. People started to scramble when all the shooting started.

Keating described Susan White, a CHS Administrator, as being positioned behind her in the hallway located adjacent to the principal's office. Mikesell was also close by. Keating grabbed Susan White and "threw" her into Peter Horvath's office. followed her in and shut the door. Keating dialed 9-911 and rolled under a desk with Susan White, declaring to the emergency dispatcher that CHS was under gunfire. Keating described Peter Horvath as being in close proximity to her prior to entering his office. Keating stated when she started hearing the gunfire that she believed the gunmen were coming after her because she is known as the "School Narc." While looking through the glass and while staying on the telephone with the 911 dispatcher, she noticed three male subjects, all dressed in black. She described the first two unknown subjects as being 5'7" to 5'8" in height and the third subject wearing a bright colored hat described as a gold/yellow color with the brim facing forward. Keating told Susan White, "They're coming to get me." Keating remained under the desk and continued to hear loud noises. Keating remained under stated desk with Susan White until law enforcement SWAT

members arrived. Keating stated she lost all track of time during the shooting.

In response to questions about individuals was a CHS student, Zachery Heckler, a senior. Keating stated Heckler is skilled in computers and got "all" the locker combinations last year. Keating asked Heckler in January, 1999, if he would help in designing and building a computer program that would break down student information such as parking assignments, locker assignments, etc. The CHS staff found out that Keating had asked Heckler to assist her in a student program due to him being competent in programming. The CHS staff became upset with her when they found out Heckler was into the CHS computer system. When Heckler was advised he would not be permitted to complete his programming task, he became upset. He commented that he would return and do something to the school. Keating stated Heckler and Dylan Klebold spent a lot of time together. stated Heckler put a lock on the computer identified as a "Newbus." Keating was called into Principal DeAngelas' office with the vice principal regarding Heckler and his access to the school computer. Keating stated in February, 1999, the "Newbus" was still running. Heckler came to Keating's Office in February, 1999, with a clenched fist saying, "They're going to get it." Keating stated Heckler drives a blue colored vehicle and parks in space #259.

Keating provided the name of Chris Morris, describing him as always wearing a green beret, dark glasses, and is known to be a member of the Trench Coat Mafia (TCM). His personality is described as "defiant and sneaky." He hangs out in the commons area of the cafeteria leaning against the trash cans. Morris is known to be a friend of Dylan Klebold. Morris recently commented to Keating, "I'm a good kid - you haven't caught me."

The name of Brooks Brown was mentioned, described as a "Total Wacko." Keating stated Brooks Brown's parents came to the school during mid-year of 1998 seeking an "intervention" due to Brooks' radical behavior. The parents of Brooks commented that their son was "becoming weirder," he was not bathing, and believed him to be gay. Keating stated toward the end of the 1998 school year that Brooks was "out of control" and needed counseling. Keating stated Brooks came to her in November, 1998,

and told her that he was getting his act together. He was reported to have stopped wearing his trench coat at that time, was growing a beard, dyed his hair black, wore sagging pants, being described as "strange." Approximately one week ago, Brooks mother called her reporting Brooks had run away from home. He was reported to have had a fight with his parents. He is known to be working as a waiter at the International House of Pancakes (IHOP), located at Cross and Bowles in Littleton, Colorado. Following an argument with his parents one night, he stayed at the IHOP over night. Recently, Brooks came to her office and told Keating that he was not getting along with his parents, especially his mother because she was making him do chores. Keating stated Brooks had a close relationship with Dylan Klebold. Keating stated Brooks always talking to Dylan and that he hated the students of Columbine High School.

Keating provided associates of Harris and Klebold: Kristen Theabold (phonetic), Eric Dutroe and Pat McDuffee. No specifics were provided relating to their relationships with the Trench Coat Mafia and known associates.

Joe Stair (phonetic) was mentioned, stating that he had graduated from CHS in 1998 and still was known to hang around school. Keating stated Stair was friends with Harris and Klebold. She believes Stair to be working at Arby's located in proximity to the Southwest Plaza Mall, Littleton, Colorado.

Keating stated she has never heard of anything related to explosives or bombs in connection with students at CHS. was reported to have sold "fake cocaine" last year to Eric Harris, Chris Morris and Eric Dutroe. Chantel Beery (phonetic) is reported to be an associate of the TCM. Crystal Bragazzi, CHS student, telephone number (303) 932-7855, is a student Eric Harris was known to like.

Keating stated Eric Ault, a former CHS student that never graduated was seen at school on Tuesday, April 20, 1999, wearing a green shirt and black pants. Keating stated Ault looked at her and turned away. She called Ault a "loser." Ault's best friend is Phillip Casey, another student that had gone bad and was no longer attending CHS. Eric Dutroe and John Beach are also friends of Ault. Brian Sargeant, a CHS senior, is a member

of the TCM. Paulene Colby, a CHS senior and associate and Nicole Markham are also associates of the TCM.

Keating stated Zachery Heckler, a CHS senior, has a computer disk described as being yellow in color that may be of some interest. She stated Heckler has a black bag that is filled with computer disks. She described the black bag as looking like a briefcase, leather or the appearance of leather, a handle and a shoulder strap.

Following a detailed synopsis of Heckler's access to her computer, Special Agent (SA) Matt Hellman, FBI, and Sergeant John Hicks, Jefferson County Sheriff's Department, both computer specialists, were introduced during the interview to discuss Heckler's access and known actions with the schools computer system. All present concurred that Heckler's computers and computer disks needed to be reviewed.

#### **INVESTIGATION:**

On February 22, 2001, I met with several family members of the victims of the Columbine High School shootings in order to return property belonging to the victims. Specifically, I returned property belonging to Matthew Kechter, which I returned to his father, Joseph Kechter. When returning the property, Joseph Kechter told me it was his understanding that when Matthew Kechter was shot, he had a pen in hand and he would like to know if we still have that pen and if so, he would like if returned to him. I told Joseph Kechter that I was unaware whether or not that pen had been collected and I would research it and get back to him.

On February 26, 2001 I reviewed the evidence logs and was unable to locate any pen that was collected from the body of Matthew Kechter. In an attempt to ascertain whether or not that pen was collected, I responded to the Jefferson County Crime Lab and met Acting Supervisor Chris Loptien. I explained to Loptien that I was attempting to find crime scene photographs or videotapes that may not be in the evidence vault so I could ascertain whether or not the pen in Matthew Kechter's hand was collected. Loptien then took me into the locked area of the crime lab where Columbine photographs and crime lab diagrams and reports are located. Loptien advised that he was not familiar with how all the items are organized and stated that the previous Lab Supervisor Chris Andrist, had been the person in charge of the Columbine photographs and documents pertaining to the crime lab. While looking at the shelves where the books are kept, Loptien discovered a cardboard box that had several documents that appeared to be copies. Also included in this box was some compact discs that had digital images and scanned images as well as zip files that had images on them. Loptein advised me that he was not familiar enough with the contents of the box to make a determination if these were copies or originals. I then offered to go through the box to make that determination.

In reviewing all of the contents in the cardboard box, I found the majority of the items were copies of reports pertaining to crime scene documentation and all of these copies are already contained in the Investigative Files. I did however locate some original documents that I had never seen before and were not included in the Investigative Files. Specifically, I found original drawings from the autopsies of John Tomlin, Matthew Kechter, and Cassie Bernal. These are drawings showing the wounds inflicted on the bodies of these three victims. It should be noted that I have previously submitted copies of drawings of the autopsies of Cassie Bernal and Matthew Kechter, however these are the originals and will be added to those drawings already in the evidence vault.

I also found an original report by CSP Officer Dan Overturf that is dated 04-27-99. This report is documenting a male who contacted Trooper Overturf on 04-27-99 and told him that there was information on the Internet about how to make pipe bombs. This is not new information and this issue was being looked into in April 1999.

I found another original report dated 04-26-99 by Jefferson €ounty Sheriff's Office Sergeant Lee Ulshoffer in which he interviewed Randy Francis. Francis had responded to Columbine High School on 04-26-99 and provided Ulshoffer with information about a subject with a first name of Mark who had sold a 9mm to Harris and Klebold. This information is most likely referring to Mark Manes and the issue has already been addressed.

I found an original report dated 04-26-99 by JCSO Sergeant Scott Pocsik. This report documents that two Columbine students by the name of Jennifer Tindall and Kristen Schoenhoff had provided information to Sgt. Pocsik. Both students filled out a written statement. Other officers interviewed these students and this is not new information.

I found another original report from Arapahoe County Sheriff's Office Officer Wayne Belohlavy that documents his response to Columbine High School on April 20, 1999. Although this report is the original, it appears a copy of this report is already contained in the Investigative Files. The original will replace the copy of the report.

In addition, at the bottom of the box, I located in a plastic bag and seven pages of documents that appeared to be school homework. The school papers appear to be authored by Nathan Dykeman, Dylan Klebold, and Eric Harris. These documents are in a plastic bag that has writing outside of the bag that says "06-08-99, 1000 hours, SCA received from instructor".

Lastly, I found a flattened piece of metal that is in a bag with a yellow post it note. The yellow post it note indicates that this evidence was found in the sidewalk near the library, west going to the parking lot. According to the note, Brent McSwain, DOB/03-04-58, found it on 06-18-99 at 1345 hours. It was then given to JCSO Deputy S. Flowers.

The original reports were subsequently placed in the investigative files. The school papers and flattened piece of metal were subsequently placed in the JCSO evidence vault on 03-07-01.

On March 6, 2001 I interviewed Chris Andrist, the previous supervisor of the JCSO Crime Lab. I explained to Andrist that I had located a box with the above documented reports and evidence and asked if he could recall how they came to

be in the Crime Lab vault. Andrist stated that he specifically recalls getting the English papers of Dykeman, Klebold, and Harris on 06-08-99 from an English Instructor at Columbine High School. Andrist said the three students had turned them in to their English instructor and after the Columbine shooting, the instructor located these papers and gave them to Andrist. Andrist stated that he most likely placed them in a box to give to me however he inadvertently forgot and they were instead left in the crime lab, which is also a secured vault.

I asked Andrist about the original reports and he stated he had never seen those reports before and has no idea how they got into the cardboard box but speculates the reports may have inadvertently been sent to the lab. He surmised that someone in the lab may have placed them with the rest of the Columbine documents that the lab have.

I then asked Andrist about the flattened piece of metal and he advised he does remember taking custody of that. Andrist said that Deputy Flowers gave him the bag with the flattened piece of metal after a construction worker who was involved in the remodeling of Columbine High School found it. Andrist said he recalls telling Deputy Flowers that he would take possession of the piece of metal and hold on to it for safekeeping in the secured evidence area of the lab. Andrist said he told Deputy Flowers that he needed to document exactly how he came into possession of this piece of metal in a report and then provide that report to either myself or Chris Andrist. Andrist said he subsequently placed that piece of metal in the original bag that Flowers gave it to him in into the secured area of the lab. Andrist said he never heard back from Deputy Flowers nor did he hear from me whether or not I had received the report from Deputy Flowers.

I did check the Investigative Files for any report generated by Deputy S. Flowers or any interview or report generated by Brent McSwain who had found the piece of metal. I was unable to find any documentation regarding this.

Deputy Flowers will be interviewed at a later time.

### **INVESTIGATION:**

On March 8, 2001 I received a fax from Assistant County Attorney Lilly Oeffler regarding a letter sent to the County Attorney's Office from CBS attorney's representing 60 Minutes. Specifically the letter addressed the Critical Incident Team interviews of all of the officers involved in discharging their weapons at Columbine High School on April 20, 1999. The main issue addressed is whether or not the Jefferson County Sheriff's Office has possession of the transcript or audio tape of the interview with JCSO Deputy Neal Gardner by Detective Russ Boatright of the Arvada Police Department.

I subsequently confirmed that the Investigative Files as well as the evidence vault do not contain any tape recorded interviews with Deputy Gardner by Russ Boatright nor do we have the transcript of any such tape. What we do have is a 9-page report by Detective Boatright documenting his interview with Deputy Gardner.

I subsequently contacted Detective Boatright of the Arvada Police Department and asked if he had ever provided those items to me. Detective Boatright indicated that shortly after the shootings at Columbine High School he was notified by his superior, Commander Debbie Grainger, of the Arvada PD who advised that she needed all of the transcripts, reports, and cassette tape recordings of any interviews conducted by the Critical Incident Team. Detective Boatright advised that he did in fact provide Debbie Grainger with the original cassette tapes as well as a lengthy transcript of the cassette tapes of his interview with Deputy Gardner. Detective Boatright advised that he specifically recalls that he had not completely corrected the transcript in terms of typos or information that the secretaries who typed the transcript had not been able to discern. I told Detective Boatright that I had checked the Investigative Files and the evidence vault and I had been unable to find the audio tape or transcript of the interview with Neal Gardner. I asked Detective Boatright if he would check his files and see if he has the originals or copies of these items. Detective Boatright said that he would check and he would contact me.

On March 13, 2001, Detective Boatright responded to the Jefferson County Sheriff's Office and provided me with a copy of an 88-page transcript of his interview with Deputy Gardner on April 20, 1999. Detective Boatright also provided me with a copy of Deputy Gardner's diagram that he prepared during the interview. I did not have this in my files.

Detective Boatright also provided me with a diagram prepared by Kim Blair that had not been attached to her report.






