ARMED AND DANGEROUS

Synopsis: To update FBI Headquarters regarding captioned mass murder case.

Details: At approximately 11:30 a.m. on 04/20/1999, the two referenced subjects entered the Columbine High School, Littleton, Colorado, and thereafter began shooting students and staff, and also utilizing explosive devices. It was subsequently determined that prior to entering the school, the two subjects planted explosive devices in and around the school parking lot, and killed two students outside the school building.

Through further investigation, it was determined that the two subjects probably committed suicide after murdering 13 individuals, students and staff. In addition to the homicide victims, there were a total of 23 other victims wounded by gunshots and bomb shrapnel. As of today, 16 of these individuals remain hospitalized with 5 being in critical condition.

To date, the FBI's sole responsibility in this investigation is to assist Jefferson County, Colorado, authorities, as requested. This includes providing two Evidence Response Teams (ERT), the Denver bomb technicians, the SWAT team and a number of Agents used for interviewing purposes. The FBI continues liaison with the Bureau of Alcohol, Tobacco, and Firearms and the U. S. Attorney's Office for Colorado.

On 04/20/1999, the Denver SWAT team assisted with the securing of a perimeter of the Columbine High School and evacuating students. Subsequently, the Denver ERT has been conducting crime scene investigations, including the crime scene investigation regarding the two fatalities outside of the school building, the area outside the school, and vehicles in the school parking lot. The Denver bomb technicians have been assisting EOD personnel in searching for numerous explosive devices at the school, in vehicles, and at residences.

Denver Agents have interviewed an associate of the subjects, which has produced a lead regarding an individual who may have sold at least one weapon to the subjects. The cooperating witness has volunteered to take a polygraph to verify his information. [REDACTED]

Denver intends to continue to provide any services needed as requested by Jefferson County Sheriff's Office. It is fully anticipated that this matter will remain a local homicide (mass murder) investigation.

A total of approximately 400 law enforcement officers from 24 agencies have been involved in the investigation.

Denver has requested assistance from the Critical Incident Response Team/EAP to assist Denver employees who were at the crime scene and who had students in this school.

After being advised of the identity of the interviewing agent and the nature of the interview she provided the following information:

On April 19, 1999 at approximately 10 PM [redacted] was logged on to her internet server, America OnLine (AOL). [redacted] believes that she logged in under the screen name [redacted]. [redacted] entered a chat room, under the name [redacted] which she often visits called "BOB ENYART LIVE". [redacted] describes this chat room as conservative and right wing. While in BOB ENYART LIVE, [redacted] had an electronic conversation with two screen names. One of the screen names was [redacted] which is a screen name which [redacted] recognized and has talked to previously. The second screen name was [redacted] which is not a familiar screen name to [redacted].

During the course of the conversation [redacted] made statements to the effect that something bad was going to happen in Colorado or North Carolina on April 20, 1999. [redacted] further made references to the holocaust, Adolph Hitler's birthday and a fire. Toward the end of the conversation [redacted] stated to [redacted] keep your eyes open.

On April 20, 1999, approximately 10 PM [redacted] logged onto AOL and entered the chat room BOB ENYART LIVE. Once again [redacted] was in the room and was referring him/herself as the "mole" and that he/she had to go back under.

[redacted] frequently visits the chat room BOB ENYART LIVE and [redacted] believes that [redacted] is a 17 year old boy, possibly from Colorado.

Synopsis: To advise FBI Headquarters and Denver Division regarding the status of an investigation involving an incident at Evans High School in Columbia County, Georgia.

Details: On 04/21/1999, Sheriff Clay Whittle, Columbia County Sheriff's Office (CCSO), Appling, Georgia, contacted the Augusta Resident Agency office of the FBI. Sheriff Whittle advised the CCSO had questioned two local Evans High School (EHS) students on 04/19/1999, regarding death threats they reportedly made at EHS. EHS serves a suburban area near Augusta and has a student population of approximately 1,500 students. To date, although numerous students and faculty members have been interviewed, CCSO Investigators have been unable to substantiate that such threats were made. The EHS students who allegedly made the threats are identified as [redacted] a white male, Date of Birth [redacted]

During the sheriff's office interviews of the subjects, with their parents present, consent was given to search the two residences. During a search of [redacted] bedroom, a locked briefcase was found. The briefcase contained a Grendel, Model .380, semi-automatic pistol. The pistol reportedly belonged to [redacted] father, who is in the Army, currently stationed in Korea.

A search of [redacted] residence revealed seven additional firearms, all reportedly belonging to [redacted] father. The firearms included two pistols and five long guns. Other items seized by the CCSO include two personal computers, one at each residence, several computer hard drives, as well as Excalibur and Samurai type swords.

[redacted] were placed in custody, charged with underage possession of a handgun. The two are currently undergoing psychological testing.

Investigators noted that [redacted] are believed to be practicing some type of witchcraft, in that a large altar with witchcraft symbols was located in [redacted] bedroom. [redacted] also reportedly have an area where they participate in war-type games. Based on a tip from a fellow student, a Remington 12-gauge shotgun, located by Investigators on 04/22/1999, was found in this area. Investigators have further confirmed that [redacted] did frequently wear trench coats to EHS, and would also dress in all black outfits with combat boots.

As a result of the recent events in Littleton, Colorado, Sheriff Whittle requested FBI technical assistance in examining the seized computers. Sheriff Whittle was concerned that [redacted] had communicated with members of the Trenchcoat Mafia in Littleton or had visited the same websites. Due to the Atlanta Division computer specialists participating in a Field Training Exercise in Knoxville, Tennessee, Columbia Division was contacted for assistance. Columbia computer specialist [redacted] immediately responded and assisted the CCSO with computer analysis. The CCSO is greatly appreciative of his expertise and professionalism.

Although numerous rumors abound, thus far, no evidence has been found to indicate [redacted] communicated with members of the Trenchcoat Mafia in Littleton. This is contrary to many news reports, fueled by rumors, that are currently circulating throughout the region. However, it should be noted that the computer analysis has not been completed and evidence establishing such a link could arise at a later time.

Details: On April 21, 1999, [redacted] telephone [redacted] telephonically contacted the FBI and furnished the following information:

[redacted] said that she was browsing the INTERNET when she came across a screen name of [redacted] which she said was operated by [redacted] of Colorado, year of birth 1981. [redacted] said that this particular address talked about the "Trench Coat Mafia" and how he applauded the shootings that occurred at Columbine High School in Littleton, Colorado on Tuesday, April 20. [redacted] said that this sight also discussed how he wished that more damage and harm could have been inflicted against the victims. [redacted] said that the whole nature of this particular INTERNET sight had a sense of hate.

Because of the fact that the entire date of birth could not be furnished concerning [redacted] National Crime Information Computer (NCIC) checks were not performed.

A search of Universal Index failed to disclose any references for a [redacted] with a year of birth of 1981.

Enclosures: Paper copies of two e-mail messages received by Coquille, Oregon radio station News Talk 630 KWRO regarding the shooting at Columbine High School as well as a diskette, contained in a 1A envelope, containing the e-mails in an electronic file.

Details: On Thursday, April 22, 1999, [redacted] advised the Eugene, Oregon Resident Agency that his Coquille, Oregon radio station, "News Talk 630 KWRO", received two disturbing e-mails regarding the shooting at Columbine High School in Littleton, Colorado. He indicated that his station received one e-mail of the message with the "wallpaper" behind it, which read: "I know 2 of the killers very well as well as the rest of them (not the ones who were caught or dead I only know 1 of them that was caught). I am NOT one of them but the 2 I know I have known for 4-5 years. I just want to know if anyone found a gold medallion with a bluish-red crystal like rock inside the middle of it with an engraving that says (Never again will I let it happen) If not then one of the others have it. Well thats all I know about them because I haven't talked to them for a year now...so I you have or haven't found it please e-mail me back." The e-mail had closing comments of "Sincerely, a VERY Dear Friend" and "P.S. I think it was the best fucking prank they have ever pulled". Two paper copies of this e-mail are enclosed.

[redacted] advised that KWRO received approximately 15 e-mail messages of the second message, which he described as

vulgar. This message stated: "By the way I am Very Serious and I am a member of The Trench Coat Mafia and the (sic) is a very good chance you will NOT catch us FUCKERS! FUCK THE POLICE, FUCK THE FBI, FUCK THE CIA, FUCK BILL CLINTON, FUCK YOU, AND FUCK ANYONE WHO TRIES TO STOP US FUCKERS." The bulk of the message consisted of the vulgarities repeated. One copy of this e-mail is enclosed. Both e-mails were forwarded to the Denver FBI Office Internet e-mail account on April 22, 1999 to the attention of SA [REDACTED]

[REDACTED] advised that he called radio stations up and down the Oregon Coast, and indicated that no other radio stations appeared to have been targeted. The address of the sender of the e-mail messages is listed as [REDACTED]@hotmail.com> with the recipient's e-mail address listed as "ken@kwro.com". [REDACTED]

[REDACTED] indicated that KWRO has a web site that contained a list of the names and individual e-mail addresses of KWRO employees. [REDACTED] stated that their News Director, Ken Edwards, name was listed as well as the name of their General Manager, Connie Williamson. He also advised that the shooting at Columbine High School has been the primary topic of discussion on KWRO for the past 2 days. [REDACTED] further advised that no one has called in claiming credit for the e-mail.

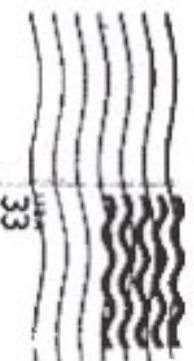

[redacted] Columbine High School (CHS), was interviewed at CHS. After being advised of the identity of the Special Agent and the nature of the interview, [redacted] provided the following information:

[redacted] described the video taping system that was in place in the cafeteria as consisting of four cameras located at the northeast corner near the soda machines, the northwest corner near the entrance to the faculty lounge, the southwest corner located above the windows, and at the southeast corner near the stairway. All cameras are set to point into the cafeteria area and operate on a clockwise "rollover" system. Each camera terminates at a VCR which is located in a custodial closet in an area east of the cafeteria. [redacted]

[redacted] are the individuals that usually change the tapes. [redacted] showed the interviewing Agent the location of the closet and the cameras.

[redacted] said the purpose of the taping system is to document activity in the cafeteria, especially students leaving trash at the tables. [redacted] procedure to periodically review the tapes to see if there is any trash located in the cafeteria and if trash is discovered to review the tape to find out which group of students left the trash, and then try to identify those students and have them clean up their mess. [redacted] finds trash on a tape [redacted] generally pull that tape out of the VCR and place it on top for later review.

On April 20, 1999, [redacted] started the tape in the morning between 7:00 am and 8:00 pm, then probably reviewed the tapes sometime between 10:00 am and 11:00 am, and may have seen trash or an object on the table and removed that tape and re-inserted another. re-wound tape to record lunchtime activity since that is a high volume time in the cafeteria.

[redacted] changing the tape before lunchtime, but is less sure whether [redacted] changed the tape several hours earlier. [redacted] probably did but has no specific knowledge of changing the tape between 10:00 am and 11:00 am.

[redacted] said that the normal procedure is for [redacted] to do a walk-through after each class period when classes occupy the cafeteria, and he believes that [redacted] would have done a walk-through at around 10:15 am. [redacted] said he is sure that the door to the custodial closet where the VCR is kept was locked each time he went there on April 20, 1999.

[redacted] said that on April 20, 1999, after the tape change which he believes would have occurred around 10:30 am, he went into the kitchen, got his lunch and [redacted] he ate lunch with [redacted] returned to the custodial closet between 11:10 am, and 11:15 am, and changed the tape. After the tape change [redacted] the kitchen and heard [redacted] voice on the radio saying words to the effect that he needed [redacted] whom [redacted] identified as the campus security policeman, in the west parking lot. [redacted] said [redacted] voice was agitated so [redacted] went into the cafeteria area from the west entrance and saw several students looking to the west into the parking lot.

[redacted] said he saw two students laying in the parking lot that appeared to have been injured. At that time he also noticed a student on his knees outside the window area to the west with a severe facial wound. [redacted] said he also saw a student laying outside the door of the cafeteria. One student wanted to pull this student in and [redacted] stopped him, feeling that the student was more likely to get medical attention outside than inside. [redacted] said that students both outside and inside were ducking from what [redacted] thought were gunshots that appeared to be coming from the north or northwest. He said the student that had been shot in the face was also facing to the north so [redacted] inferred that the threat came from that area.

[redacted] then ran into the faculty lounge to ensure someone was on the telephone calling 911. Once he verified that was in fact taking place, he ran back out and found the student that had been lying down had pulled himself half in and half out of the door. At that time [redacted] noticed that the student had been shot in the back and [redacted] suggested that they not move him further. [redacted] then went around the serving line of the cafeteria and heard and felt a large "boom" which threw him to the ground. He believes the explosion came from the cafeteria area. He said he then crawled to the kitchen where he found three cooks and two more students ducked under appliances in the kitchen. At that time he noted [redacted] running in the vicinity of the kitchen and he could hear bits and pieces of conversation over his two-way radio from persons outside the kitchen.

At that point [redacted] said things begin to quiet down somewhat so he went to the storage room and noted students had began to huddle in there, so he went back out and got the cooks and another teacher whom he believed was a social studies teacher, and helped them into the storage room. He said the social studies teacher had been wounded in the leg and was obviously in a great deal of pain. He said the teacher had been hit with something from the explosion and the teacher said it felt like he had been hit with a "full beer can."

[redacted] said shooting was going on while he was in the kitchen and until the time they went into the closet. Even after they were in the closet he would hear rustling, shots and screaming from an area he thought was above the kitchen. He estimated that the shooting went on for 20 to 30 minutes and then became sporadic. [redacted] did not know at any point where the shooting was coming from other than at some point it was louder and then became quieter. After approximately 1 1/2 to 2 1/2 hours, [redacted] and the students were directed out of the closet by police officers and taken out the west door of the cafeteria. [redacted] thinks that occurred at around 3:00 pm. [redacted] said the day of the incident he was wearing a white T-shirt and jeans.

[redacted] said that he did recall a student who was performing community service working in the cafeteria prior to the incident. [redacted] said the student's name was possibly [redacted] and would be listed on a sheet in the custodian's office.

He is quite certain that he would have noticed an odd shaped duffel bag or larger container during one of his walk throughs.

cafeteria helping to sweep the floor and wipe down tables and may have seen something. [redacted] does not know the student's name.

[redacted] wait at the northwest corner of the kitchen until approximately 10:30 am when he would go into the kitchen and get his lunch. On April 20, 1999, he said he was waiting at the northwest corner until approximately 10:50 am, when he went into the kitchen to prepare his lunch. Around 11:15 am, [redacted]

[redacted] when a young girl came running into the cafeteria and said words to the effect of, "Someones been shot." [redacted] looked out the window and saw a student laying in the parking lot close to the soccer field.

At around that time a window on the south side of the cafeteria with a Columbine symbol etched in it was blown out by either an explosion or a bullet. [redacted] screamed, "Get down" to students around him and at that time recalls hearing sporadic gunfire. [redacted] directed students to get under tables as the gunfire increased. He noticed some students were running toward the stairs and the double doors leading to the south parking lot.

[redacted] recalls hearing gunfire upstairs above the cafeteria and he went to the stairs that led to that area. He is not sure but thinks he went all the way to the music room located on the northeast side of the building where he saw students fleeing in all directions. He then retraced his steps back toward the cafeteria and library area. As he approached the top of the steps in front of the library leading to the cafeteria, he encountered a teacher he identified as [redacted] who said words to the effect, [redacted] Dave Sanders has been shot. Call an ambulance." [redacted] thinks [redacted] also may have said that two students had been shot, but he is not sure.

[redacted] reached for his walkie-talkie and as he turned back toward the library he saw a student in a black trench coat holding a pistol and what [redacted] thought was a long barreled grenade launcher. He said the shoulder weapon was strapped across the individual's chest with the butt of the weapon on the right side of the individual's body. For a brief moment [redacted] and the subject were face-to-face and he

noticed that under the trench coat the individual appeared to be wearing a white shirt. [redacted] did not recognize the individual. [redacted] turned and ran to the landing leading to the cafeteria when he heard shooting behind him. He believed at that time the individual in the trench coat was coming down the stairs behind him.

[redacted] believes that around this time he saw [redacted] whom he believes is a social studies teacher. He, [redacted] were moving toward the kitchen when he heard a large explosion behind them. [redacted] believes it was a pipe bomb and it blew [redacted] down to the ground. He and [redacted] picked [redacted] up and carried him into the kitchen where they encountered a student, whom he identified as [redacted] plus three other unidentified students. [redacted] warned them back and the students went toward the storeroom area in the rear of the kitchen.

[redacted] huddled down behind the dishwasher table and [redacted] closed the door behind them. He is not sure why the gunman did not follow them into the kitchen. He does recall that several students insisted on leaving and left on their hands and knees out the western side of the kitchen toward the door that led to the west parking lot.

[redacted] encountered [redacted] and a number of other students in the northern storeroom area of the kitchen and recalls that [redacted] and 17 students entered the storeroom and locked themselves in. He believes the cooks were locked in their office.

[redacted] then left the kitchen and went back through the cafeteria to the auditorium and found the door unlocked. As he entered the auditorium he noticed several students sitting near the top of the auditorium and he saw a teacher whom he identified as [redacted] sitting with the students. [redacted] motioned the students to come to him and all the students came down to the double doors leading into the auditorium. [redacted] told them there was an extreme emergency and to get out as quickly as possible. He believes 50 to 80 students ran out the auditorium and down what he referred to as the business hall which leads to the eastern lower section of the school.

[redacted] believes that the movement out of the auditorium drew the attention of the individual in the trench coat and as he stood at the base of the stairs he looked up and saw at least one of the individuals who was doing the shooting, coming around the corner of the stairs. [redacted] believes it was the same man he had seen in front of the library. [redacted] ran back through the cafeteria and as he ran through the cafeteria, he noticed a student lying on the floor. When he got to the end of the cafeteria [redacted] did not see the subject, so he went back upstairs and saw [redacted] near the landing of the stairs.

[redacted] again saw the shooter standing in front of the library and it is his recollection that as he and [redacted] began running down the stairs together, the shooter began firing rounds at them. [redacted] said that as he and [redacted] entered the kitchen an explosion occurred behind them and he could hear objects hitting the metal door on the serving line.

Once he and [redacted] were on the ground in the kitchen, they crawled underneath a large industrial oven, but realized that hiding place was not secure. Around this time [redacted] heard what he described as a "whoosh" and saw fire in the vicinity of the cafeteria and the kitchen. [redacted] determined that he was in a "bad place" and moved further into the kitchen. He then entered the walk-in cooler and [redacted] went into the freezer. After approximately one minute, [redacted] who was carrying a radio, called [redacted] and told him to open the door and that he was coming in the walk-in cooler. The door opened and [redacted] entered the walk-in cooler.

They propped a food cart against the door and prepared several large objects to use as weapons in case the gunman opened the door. [redacted] kept trying to make contact with two individuals, whom he identified as [redacted] on his radio. [redacted] said that [redacted] answered and [redacted] told him they were in the cooler and to tell him when it was safe to come out. [redacted] recalled hearing gunshots for a long period of time while he was in the cooler, but could not tell where they were coming from. He believes he saw shadows moving around the kitchen but did not see anyone.

At approximately 2:35 pm, a voice on the radio told him that the SWAT Team was outside the doors and [redacted] came out of the cooler.

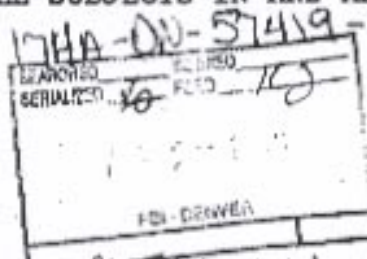

Portions of the readable text from the document provided what appeared to be bomb making instructions (which he believed were excerpts from the "Anarchist Cook Book" published on the Internet). Also legible in the document was the statement:

"I did not try this on the DELTA batch, am sure they won't be used until NBK ...";

[redacted] believed this was possibly another event yet to take place by the group. His son suspected the initials NBK may have been an acronym for some German Holiday, although he stated that was pure speculation. He had heard on the Internet that the date of the shooting was 'Hitler's' birthday and was focusing on special dates in German history.

They also found a name on the web site which they reasoned, based on name recognition only, that may be a relative or alias for one of the subjects in the shooting. The name with an associated address was:
