At [redacted] request, SA [redacted] CART Field Examiner, responded to [redacted] residence, obtained consent from [redacted] mother [redacted] and made a mirror image copy of [redacted] computer. No detailed interviews of [redacted] or [redacted] were conducted. [redacted] requested only positive information relating to their investigation be provided to them. No information was located on [redacted] computer which related to the threats to his classmates.

A cursory review of information obtained from [redacted] computer indicates he had visited the "Trench Coat Mafia's" web site apparently after the shooting. He also reviewed news articles on-line which related to the incident. No information was located which could demonstrate what, if anything, he may have done to their website.

The date and time stamp of the original computer was noted to be approximately the same as the actual date and time.

This computer uses the Windows 95 operating system and was partitioned into two drives. Only the first partition contained a logical file structure, therefore it was the only one analyzed. This partition contains 9,855 active files contained within 1,893 directories. 1,261 previously deleted files were recovered.

## Student recounts school shooting

**LITTLETON, Colo.** — Lance Kirkin strolled out of the cafeteria to sneak a smoke with two friends at Columbine High School when two shadows appeared about 50 feet away.

Within seconds, there was gunfire. More than a half-dozen bullets fired from a shotgun, a rifle and a TEC-DC 9 handgun pierced the three boys from head to toe. When it ended, one youth was dead, and Kirkin, who initially thought it was a senior prank, and another boy were injured.

As Kirkin lay on the ground, blood oozed from his leg and the left side of his face, part of which had been shattered by the shotgun blast. The triggermen said nothing and moved on to their next victims.

The three were among the first casualties of last month's shooting massacre at the school, which claimed 15 lives, including the two gunmen. Kirkin is among five students still hospitalized. He appeared publicly Friday for the first time since the April 20 rampage.

"I thought it was a dream," Kirkin, 16, said at a news conference at Denver Health Medical Center.

Joined by his parents, Michael and Dawn, and his three doctors, Kirkin relived the chilling moments that changed his life. Kirkin walked slowly with the help of crutches and sat in a chair cushioned with two bed pillows.

"I feel great," he said, mustering a smile. But "it's hard to get back to normal."

He said he believes he and his two friends were random victims. He said he cannot identify the shooters, although he remained conscious for 10 minutes afterward. A triage nurse held his head until two paramedics rescued him and whisked him to the hospital, where he remained in intensive care for two weeks. His condition has been upgraded to fair.

The most gravely injured survivor, Kirkin was shot in the face, chest, groin, leg and foot. He has undergone nearly 30 hours of surgery, including a craniotomy and skin grafts to

replace the golf-ball-size hole in his jaw.

"I had to learn to walk," a barely audible Kirkin said while placing his right hand on a bandage covering his throat. "It's been real emotional at times."

Since the shooting, Kirkin, a sophomore, has visited regularly with family and friends. He has talked with the paramedics who helped save his life. And Aerosmith, his favorite band, dedicated a recent concert to him.

"Lance took the full force of that blast," said Ernest Moore, chief of surgery and trauma services at DHMC. "His sheer survival is a miracle."

The shotgun blast was at close range, and a 9mm bullet remains lodged behind Kirkin's left knee, Moore said. One of three shotgun pellets also remains in a heart ventricle. A section of his bone and soft tissue in one leg was removed and was attached to the jaw.



While the Jefferson County Sheriff's Department is the principal investigative agency in this case, the FBI is working closely and cooperatively with that agency to ensure that all who may have been involved in this deadly assault, in addition to the two young men who committed suicide, are brought to justice. I am unable to provide any additional information about this pending investigation due to longstanding Department of Justice and FBI policy. This policy exists to protect the rights of all parties involved and to prevent any impact on any criminal charges which might result from the investigation.





Synopsis: Report threat information received by the Columbine High School task force that appears directed at a school in or near Freeport, NY, to occur on May 21, 1999.

Enclosures: Enclosed for New York are two copies of a chat log that occurred on AOL and two copies of the Online Account Profile of the suspected threat maker.

Details: During the course of the above captioned investigation, the CHS task force received a faxed copy of a chat log that shows a conversation between [redacted]. In the log, [redacted] claims that he has become emboldened by the actions of "those kids" (Harris and Klebold), and that he is going to do the same thing at his school on May 21, 1999. [redacted] claims that his name is [redacted].

Denver issued a court order to AOL to produce account information on several screen names. Included in that order was the name [redacted]. According to AOL records, the screen name [redacted] belongs to [redacted]. It is possible that [redacted] is the party financially responsible for the account and that the screen name [redacted] is being used by someone else in the household.

This information is being provided to New York to handle accordingly. No further investigation pertaining to [redacted] is being done by Denver at this time.

He mentioned Phil Duran as someone who might have more information or who might have actually gotten guns for Harris and Klebold. [redacted] at Columbine High School. His lunch hour starts at 11:15 a.m. On April 20, 1999, during his lunch hour he was seated at a table along the west windows of the cafeteria. The table was approximately thirty to thirty-five feet from the northwest door and there were a couple of tables between his table and the door. [redacted] was half done eating his lunch when the windows of a car outside exploded in the Senior Lot. Everyone in the cafeteria stood up to look out the windows. [redacted] saw two individuals outside of the school. One individual he saw only from the waist up was dressed in a white shirt and blue jeans. This person was throwing something in a side arm motion up towards the school roof. [redacted] saw him throw one or two items. The second individual [redacted] got a glimpse of was dressed in black and was taller than the other person. [redacted] did not recall any describers for the two individuals other than they were white males. A teacher came in the door by [redacted] table and told everybody to get down and get upstairs. This teacher was Mr. Sanders and he was holding his arm and may have been shot.
